

Council Highlights – June 15 & 16, 2023

Below is a summary of key decisions taken by Council at its meeting held by MS Teams and available to the public on GoToWebinar on June 15 & 16, 2023.

Election of President and Vice President

Council elected by acclamation Amanda Lee as President and elected Derek Reibeiro as Vice President.

Council appointments

Council approved the Nominating Committee recommendations regarding appointments to CMRITO's committees.

2024 Council election date

Council set the date for the next election of professional members to Council as Monday, April 1, 2024.

Finance and investment reports

Council received and approved the Finance and Audit Committee Report, the Q1 2023 Financial Report, and the Q1 2023 Investment Report.

Fee Review

Council received a report from the Finance and Audit Committee regarding membership fees, and resolved that CMRITO fees, as set out in By-law No. 60, be kept at the current level for 2024.

Accreditation and certification

Professional Conduct and Regulatory Affairs Director Elizabeth Urso presented to Council on the accreditation status of Mohawk College of Applied Arts and Technology's Diagnostic Cardiac Sonography program, which was accorded an Accredited status by EQual Accreditation Canada.

Strategic Plan & Operational reports

Registrar & CEO Pree Tyagi presented an update on the various activities carried out by CMRITO in support of the 2023 Operational Plan and the CMRITO Strategic Plan 2022-2024.

Council received and approved the CMRTO Balanced Scorecard Report for 2023 Q1. The 2023 Q1 Dashboard is available on the CMRITO website.

CMRTO Annual Report 2021

The 2022 CMRITO Annual Report was approved by Council and posted to the CMRITO website. The report will be sent to the Minister of Health.

Registrar & CEO's Report

Registrar & CEO Pree Tyagi provided a verbal update and discussion on current issues and new items including:

- the updated 2023 Risk Register with proposed changes, which was approved by Council
- a review of the letter from the Ministry of Health's Health Workforce Regulatory Oversight
 Branch regarding the authority of Respiratory Therapists to use ultrasound in their practice
 without delegation and outlined how the College had communicated these changes to
 members

Emergency Class of Registration Regulation Consultation

Registrar & CEO Pree Tyagi updated Council on CMRITO's May 19, 2023 submission to the Ministry of Health of the amendments to the proposed Registration Regulation made under the MRITA to create an emergency class of registration. On June 1, 2023, we received a letter regarding the Ministry's plan to process the emergency class proposals for all health Colleges.

Independent External Legal Counsel Sarah Yun, WeirFoulds LLP, assured Council that CMRITO's two submissions before the Ministry, including the Registration Regulation, will not be impacted by the Ministry's push to pass an emergency class for all Colleges. CMRITO will be in compliance with the Ministry's directives by June 23, 2023.
