# 1. Background

Under section 20 of the Fair Access to Regulated Professions and Compulsory Trades Act, 2006 (FARPACTA), which is substantially similar to section 22.7(1) of Schedule 2 of the Regulated Health Professions Act, 1991 (RHPA),

"A regulated profession shall prepare a fair registration practices report annually or at such other times as the Fairness Commissioner may specify or at such times as may be specified in the regulations".

Section 23 of FARPACTA and Section 22.9 of Schedule 2 of the RHPA then go on to indicate that the Fairness Commissioner shall specify the form in which these reports shall be prepared, along with the required filing dates. This section also stipulates that a regulator must make these reports public.

It is pursuant to these authorities that the Office of the Fairness Commissioner (OFC) has required that each regulator complete its 2023 Fair Registration Practices Report (FRP).

Please note that this report covers the time-period from January 1 to December 31, 2023.

The FRP:

- Collects information about the organization, applicants to the profession and current membership.
- Provides information to the public about how the organization has implemented fair registration practices during the reporting period.
- Helps the OFC to successfully undertake the education and compliance activities which include monitoring, applying a risk-informed compliance framework, assessing performance, and sharing best practices.
- Determines whether the regulator is complying with recently enacted legislative and regulatory provisions designed to reduce barriers for domestic labour mobility and internationally trained applicants.
- Identifies trends across regulated professions and regulated health colleges.

Please note that the 2023 version of the FRP has changed from the previous version in terms of both form and content as the OFC's enabling statutes have evolved and as the office migrates to a more permanent portal-enabled database solution.

Applicants to the regulated professions and compulsory trades must fulfil registration requirements to practice their profession or use a professional title. Examinations The Registration Regulation in 4.(1)2, 4.1(1)2 and 4.2(1)2 requires that the applicant must have successfully completed the examination set or approved by the Council in one or more of the specialties. The CMRITO issues certificates of registration in five specialties, radiography, nuclear medicine, magnetic resonance, radiation therapy and diagnostic medical sonography. The examinations that have been approved by the CMRITO Council are the examinations of the Canadian Association of Medical Radiation Technologists (CAMRT) in the specialties of radiography, nuclear medicine, magnetic resonance, radiation therapy and the examinations of Sonography.
The Registration regulation in sections 4.(1)3 and 4.1(5), 4.1.(1)3 and 4.1.(1)5, 4.2(1)3 and 4.2(1)3 requires that an applicant must have

	engaged in clinical practice in one or more of the specialties within the five years immediately preceding the date of their application or must have successfully completed a program referred to in the education section above within the five years preceding the date of their application. Applicants are required to provide a letter of confirmation of employment as a medical radiation and imaging technologist in their specialty from their most recent or current employer. The letter must confirm the last date of employment. Where an applicant has completed a program outside of Canada that the Registration Committee considers to be substantially similar to one of the approved programs in Ontario the applicant is also required to provide the Registration Committee with satisfactory evidence as to the applicant's competence to practise in Ontario as a medical radiation technologist in one or more of the specialties. The forms that an applicant must provide to satisfy this requirement can be found on pages 30-40 of this application- guides/international-application-guide.pdf
Language requirement	The registration regulation in section 3.(1)5 requires that an applicant must be able to speak and write either English or French with reasonable fluency. The CMRITO Registration Committee accepts the following as proof of language fluency in English or French: 1. Proof that an applicant's professional training was completed in English or French, or 2. Proof of completion of one of the following: • internet- based (iBT) TOEFL (Test of English as a Foreign Language) with a minimum total score of 73, and a minimum score of 21 in speaking; or • paper-based TOEFL with a minimum score of

	500 and TSE with a minimum score of 40° or •

Fair access legislation requires regulators to take reasonable measures to ensure that any third parties undertake assessment of qualifications in a way that is transparent, objective, impartial and fair.

College of MEDICAL RADIATION and IMAGING TECHNOLOGISTS of Ontario takes the following measure(s) to ensure fair and timely assessments:

The CMRITO does not use any third-party providers to assess applicant qualifications. All applications from applicants who have completed their education and training outside of Canada are required to be assessed by the Registration Committee for substantial similarity to one of the approved programs in Ontario. The third-party agencies that the CMRITO does use to deliver on its mandate are the two national professional associations who deliver the national certification examinations. Under Ontario Regulation 866/93, an applicant must successfully complete the examination(s) set or approved by the Council in one or more of the specialties. The College Council has approved the certifying examinations of these national associations by policy for this purpose. The CMRITO has confidential written agreements with both these providers that include several measures to ensure accountability of the third-party providers. The agreements with all providers set out expectations for both parties in accordance with the RHPA and the Health Professions Procedural Code and include provisions to ensure privacy and confidentiality, and transparency, objectivity, impartiality, and fairness in their assessment processes. As all applicants from the CMRITO are assessed by the Registration Committee, service timelines are not relevant as no applications are evaluated by the third-party provider. There are also no restrictions on the number of available exam seats. Both examination providers are required to have an appeal mechanism and the information for the process is included on their websites.

# 5. Accomplishments, risks and mitigations

Key accomplishments and risks pertaining to fair registration practices during the reporting period are summarized below.

### A. Accomplishments

- In 2023 all health colleges were required by legislation to have an emergency 1 class of registration. This emergency class aims to address temporary health human resources shortages during emergencies such as the COVID-19 pandemic. To establish an emergency class of registration, CMRITO amended its Registration Regulation. The CMRITO staff have developed an application form and guide for this class of registration, which will be made available on our website when/if an emergency is declared, and the class of registration opens. 2 The CMRITO Registration Committee added 4 additional language fluency tests to the list of tests available to applicants to demonstrate their fluency in English or French. The additional tests are: • CELPIP General (Canadian English Language Proficiency Index Program) test with a minimum score of 7 in speaking and a minimum score of 7 in writing; or • TEF (Test d'Evaluation de Français) test for assessment of fluency in French with a minimum score of 310 in speaking and a minimum score of 310 in writing; • TCF (Test de Connaissance du Français) test for assessment of fluency in French with a minimum score of 10 in speaking and a minimum score of 10 in writing; or • PTE (Pearson Test of English) test for assessment of fluency in English with a minimum score of 68 in speaking, and 69 in writing. These tests are also approved by Immigration Canada for use by new immigrants coming to Canada. Adoption of these tests reduces the costs to applicants. 3 The CMRITO in 2023 has continued with our journey to foster diversity, equity and inclusion in all CMRITO processes and programs. The CMRITO has continued to provide Council and Committee members with education and training to improve understanding related to DEI. Through our partnership with the Canadian Centre for Diversity and Inclusion (CCDI) the CMRITO continues its learning journey to build a more inclusive Canada by bringing
  - continues its learning journey to build a more inclusive Canada by bringing together and supporting people through thought leadership and education. In 2023, Raj Anand, LLB, a senior civil litigation, administrative and human

rights lawyer and a former bencher of the Law Society of Ontario developed and delivered a workshop on human rights legislation to all CMRITO staff, Council and Committee members. In 2023, the CMRITO also developed and delivered education and training for all registration staff on unconscious bias using some of the excellent resources from CCDI.

4 The Registration Committee continues to seek opportunities to streamline the process for applicants to meet the registration requirements. In 2023, the Registration Committee implemented a policy approved late in 2022 (Policy 10.20 Work Authorization Exemption) to exempt all applicants from the requirement to provide proof that they are authorized to work in Canada. This policy change assists applicants who are applying for registration from a location outside of Canada. There is often a loop created in the immigration processes (e.g. Provincial Nominee Program) where an applicant needs to demonstrate that they are registered with the regulator to be approved for immigration, but the regulation requirement is that an applicant cannot be registered until they provide proof that they are either a Canadian citizen, permanent resident or authorized under the Immigration and Refugee Protection Act to practise the profession. This policy exempts applicants from this requirement for the purposes of registration.

The CMRITO has experienced a significant increase in the volume of international applicants applying for registration in the 2022-2023 period. This has resulted in an increase in the timelines for issuing decisions to applicants. The	The Registration Committee continued to meet with increased frequency in 2023 to meet the demand and continued the use of smaller panels of the Committee to be able to review an increased number of applications at each meeting. The Registration Committee also continued the electronic approval process for issuing Decisions, Orders and Reasons on all applications that were reviewed. In addition to process and technology improvements that were implemented to improve efficiency, the CMRITO Council determined that additional staffing resources were necessary to manage the increased volumes. In 2023 a new registration staff position was created and new staff were recruited and trained.

Applicants typically have five years from the date they completed their educational program in medical radiation and imaging technology OR five years from the last date they engaged in practice in the profession of medical radiation and imaging technology to complete all remaining requirements for registration as set out in the Registration Regulation. The applications that have expired in 2023 therefore may relate to applications that were submitted as early as 2018. Applications in the "successful" group include applicants who became registered or who met all the registration requirements and became eligible for registration. ### L. Data Notes

Please note that for B.10 that all international applications are subject to an internal review in order for the CMRITO Registration Committee to determine if the educational program completed by an applicant is substantially similar, but not equivalent, to one of the approved programs in Ontario. No decision has been made on these applications prior to the review by the Registration Committee. Should an applicant not agree with the decision of the Registration Committee they are then able to appeal their decision and apply for an external review to the Health Professions Appeal and Review Board (HPARB). For B.12 Applicants typically have five years from the date they completed their educational program in medical radiation and imaging technology OR five years from the last date they engaged in practice in the profession of medical radiation and imaging technology to complete all remaining requirements for registration as set out in the Registration Regulation. The reasons why an applicant may not meet the registration requirements in the provided timeframe are many and varied, and are not provided to the CMRITO by the applicants.

# 8. Changes Related to New Legislative and Regulatory Requirements

By Ontario law, regulated occupations must provide registration practices that are transparent, objective, impartial and far. Non-health occupations are governed by the *Fair Access to Regulated Professions and Compulsory Trades Act, 2006 (FARPACTA)*, while health professions are governed by *the Regulated Health Professions Act, 2011 (RHPA)*.

In 2021, both statutes were amended to incorporate substantive provisions to:

- **A.** Eliminate the use of Canadian experience requirements except under prescribed circumstances.
- **B.** Streamline language proficiency testing requirements.
- **C.** Provide for the continuity of registration processes during emergency situations.

D. Set registration time limits. (FARPACTA only)

College of MEDICAL RADIATION and IMAGING TECHNOLOGISTS of Ontario has made the following changes to comply with these new legal obligations:

#### A. Canadian Experience

#### Change required: No changes required

College of MEDICAL RADIATION and IMAGING TECHNOLOGISTS of Ontario has taken the following measures to comply with legislative requirements on eliminating Canadian experience requirements unless an exemption is granted or an alternative is identified that meets criteria prescribed in regulations (non-health regulators) or the exceptions in legislation are met (regulated health colleges).

#### **B.** Language Proficiency Testing

#### Change required: Yes

College of MEDICAL RADIATION and IMAGING TECHNOLOGISTS of Ontario has taken the following measures to comply with recent legislative changes requiring that regulators accept language proficiency testing results derived from any of the tests accepted for immigration purposes to satisfy their language proficiency requirements:

The CMRITO Registration Committee has approved the addition of four additional language fluency tests to include all tests accepted for immigration purposes to satisfy the language proficiency requirements.

College of MEDICAL RADIATION and IMAGING TECHNOLOGISTS of Ontario offers applicants the following options to demonstrate language proficiency.

- IELTS (General)
- CELPIP (General)
- TEF Canada
- TCF Canada

- Other language proficiency tests
- Education in English or French

### C. Emergency Registration

#### **Change required: Yes**

College of MEDICAL RADIATION and IMAGING TECHNOLOGISTS of Ontario has taken the following measures to comply with requirements to establish an emergency class (health colleges) or develop an emergency registration plan (nonhealth regulators).

To establish an emergency class of registration, CMRITO amended its Registration Regulation.

## **Glossary of terms**

**Applicant:** An individual who has applied for membership in a regulated profession or compulsory trade, with the associated rights to practice their profession / trade or use a professional title.

**Domestic labour mobility**: Applications subject to the Canadian Free Trade Agreement, which stipulates that a certificate issued by one province or territory should be recognized by all others unless there is an exception due to public health, safety and security reasons.

**Internationally educated / trained**: An individual whose initial professional education was not from a Canadian educational institution, or who is applying for trade certification based on experience gained outside Canada. This category includes individuals with education / training in the US and other countries. It also includes individuals who completed their initial professional education outside Canada and later addressed gaps with courses or a bridging program based in Canada.

**Jurisdiction of initial training**: For professions, the jurisdiction in which an applicant obtained their initial professional education used in full or partial fulfilment of registration requirements. For trades, the jurisdiction of initial trade experience listed on a Trades Equivalency Assessment (TEA) application.

**Member**: An individual who has satisfied the conditions for registration in their profession / trade and has been granted the right to practice and/or the right to use a professional designation or title. Members may hold a full license to engage in independent practice, or they may hold an alternate class of registration.

**Racial identity**: Voluntary self-report data of racial identity as a social description. Follows categories identified in the Ontario Anti-Racism Directorate Data <https://www.ontario.ca/document/data-standards-identification-and-monitoringsystemic-racism> .

**Registration requirements**: the entry-to-practice requirements that that an applicant must meet to be granted full membership in a regulated profession or trade, with the associated right to practice or right to use a professional title.

- **Academic requirement**: The formal education, or equivalent, that is required for licensing or certification in a particular regulated profession or trade.
- **Experience requirement:** The experiential training or work experience that is required for licensing or certification in a particular regulated profession or trade.
- **Language requirement**: The level of language proficiency that is required for licensing or certification in a particular regulated profession or trade, and the language proficiency tests accepted in fulfillment of this requirement.

**Third party service provider**: An external organization that assesses applicant qualifications on behalf of the regulator.
