

Council is the governing body of CMRITO and is responsible for regulating the medical radiation and imaging technology profession in Ontario and ensuring public protection. Composed of members of the public appointed by the Ontario government and elected professional members registered in each of CMRITO's five specialties (radiography, radiation therapy, nuclear medicine, magnetic resonance, and diagnostic medical sonography), Council determines the College's strategic direction and ensures that CMRITO meets all its statutory objectives. JAY A. NEADLES


Jay A. Neadles ended his nine-year term on CMRITO Council and his four-year tenure as Council Vice President in June 2022.



COVID-19 UPDATE – END OF EMERGENCY DIRECTIVES

On June 8, 2022, the province's Chief Medical Officer of Health, Dr. Kieran Moore, issued a statement confirming the end of most of Ontario's masking requirements on June 11, 2022. Dr. Moore also announced that the remaining emergency Directives would be revoked and replaced with Ministry of Health guidance for health care workers and organizations, which were issued on June 10, 2022.

QUALITY ASSURANCE NEWS

CMRITO's mandatory Quality Assurance (QA) Program is designed to ensure that all members maintain their competence in an ever-changing health care environment. The QA ePortfolio is very flexible and permits members to direct their own continuing education and professional development activities in topics that interest them and benefit their current practice area(s).

The peer and practice assessment component of the QA Program has been conducted on a randomly-selected group of members by means of a Multi-Source Feedback (MSF) assessment which requires a self-assessment, peer and co-worker assessments, and patient assessments using a survey tool based on the CMRITO Standards of Practice. The MSF assessment has been on hold since the beginning of the COVID-19 pandemic due to the difficulties in maintaining infection control practices while asking patients to complete paper feedback surveys of their MRIT.

One of the initiatives in the strategic plan for 2022 is to review and update the CMRITO peer and practice assessment, including the MSF assessment. The QA Committee and staff will be working on this initiative throughout the year. Stay tuned for more information about the new peer and practice assessment in the future.



QA EPORTFOLIO ASSESSMENTS

This year, 2,282 members have been randomly selected to submit their 2022 QA ePortfolios for assessment. These members were notified by email on May 12, 2022 of the requirement to submit their 2022 QA ePortfolios for assessment no later than January 6, 2023.

Were you selected? If so, there will be a reminder alert on your CMRITO Member & Applicant Portal (MAP) and a copy of the QA assessment notice in the 'QA Notices' section. You'll also see a 'Submit' button on your 2022 QA ePortfolio dashboard. When you've completed all three sections of your QA ePortfolio and are ready to submit it for assessment, just click the 'Submit' button.

TIPS FOR COMPLETING YOUR QA EPORTFOLIO

The QA ePortfolio and the QuickQA App were updated this year to make it easier to record your continuing education and professional development activities and complete your self-assessments. One important change to note is that you'll need to click the 'Finish' button to lock in your entries once you have completed each section of the QA ePortfolio. Clicking this 'Finish' button tells the system that you will not be making any more changes to your QA ePortfolio.

But don't worry; if you want to edit your QA ePortfolio, you can do so by clicking the 'Reopen' button, making your changes, and then clicking 'Finish' again!

THAT'S A GOOD QUESTION!

Being a regulated health professional is a complex role. We're happy when MRITs ask us to help them understand topics like practice standards, quality assurance requirements or the role and responsibilities of CMRITO in regulating MRITs. In this section of Insights we will answer some of your most frequently asked questions.



What imaging exams are Nurse Practitioners authorized to order?

Nurse Practitioners (NPs) have been authorized to order x-ray examinations and diagnostic ultrasound for a number of years. As of July 1, 2022, NPs are now authorized to order computerized tomography (CT) scans and magnetic resonance imaging (MRI) scans.

Changes to regulations O. Reg. 543/90 (X-ray Safety Code) made under the *Healing Arts Radiation Protection Act* (HARP Act) and O. Reg. 107/96 (Controlled Acts) made under the *Regulated Health Professions Act, 1991* (RHPA) authorizing NPs to order CT and MRI scans, have been made by the Ministry of Health to reduce unnecessary delays in patient care resulting from the need for multiple visits and to lessen wait times to access care from authorized providers.

The College of Nurses of Ontario (CNO) has established standards for NPs to support safe practice when ordering x-rays, ultrasounds, CTs and MRIs. Please visit the CNO website at www.cno.org for more information.

MRITs who perform CT or MRI examinations on the order of an NP or other authorized health care professional will continue to follow the protocols and medical directives established in their departments regarding the administration of contrast media and other authorized acts to support the performance of the procedure.

CMRITO IS NOW A VIRTUAL ORGANIZATION

Effective May 2, 2022, the CMRITO office has permanently moved to a remote workplace. Although we have become a virtual organization, there is no change in how you contact us. You can still reach us by email and telephone, or through the [contact section of our website](#).

The CMRITO office first moved to remote operations with to the declaration of a state of emergency due to the COVID-19 pandemic in March 2020. Since that time, staff have been working remotely from their homes and all Council and statutory committee meetings have been held by videoconference.



Over the past few years, the College has taken many steps to enable our transition to an online workspace, including:

- proactively invested in office practices, emerging technologies and equipment
- shifted to electronic communications
- migrated our database and systems to the Cloud
- implemented electronic agendas for Council and committee meetings
- introduced secure business software for business communications, collaboration, document sharing, project management and videoconferencing

All of these changes have enabled the College to deliver on its commitment to increased transparency and accountability to the public through the live broadcast of Council meetings via webinar.

Council has approved the sub-leasing of the office space at 300 - 375 University Avenue, Toronto and hopes the College will recover most of its office rental costs through this initiative.
